ARTICLE 15. Performance and Payment Bonds

A Performance and Payment Bond are required for contracts involving construction or facility improvements exceeding \$100,000.00. If Bidder's Bid exceeds \$100,000.00 the following shall be applicable:

1. Bidder shall provide a performance bond in the full amount of the Contractor's Bid Price, guaranteeing the performance of the terms of the Fixed Price Design-Build Contract for the stipulated price within the time specified for completion ("Performance Bond").
2. Bidder shall provide a payment bond in the full amount of the Contractor's Bid Price assuring payment as required by statute of all persons supplying labor and materials in the execution of the work provided for in the Fixed Price Design-Build Agreement ("Payment Bond").
3. Bonds shall be obtained from companies holding certificates of authority as acceptable sureties pursuant to 31 CFR, part 223, "Surety Companies Doing Business with the United States."
4. **Bidder shall include the original performance bond and the original payment bond with its "Contractor's Bid Documents" submitted to AURA.**
